Our work around Indigenous engagement continues and will be an ongoing initiative as we move forward. In the fall of 2022, we hosted an Indigenous sharing circle at our National Service Centre that was open for all staff to attend. This special event was led by Clayton Sandy, a member of the Sioux Dakota First Nation. This was an immersive experience designed to transform negative perceptions of Indigenous People and engage in reconciliatory action. We are so grateful to Clayton for his continued engagement, most recently with a group of volunteers from all sections.

The inaugural World Ice Skating Day was launched by the ISU on December 4, 2022 and Skate Canada participated by hosting a special event in Winnipeg, Manitoba with 31 young skaters, including 8 young Filipino skaters from the Filipino community and 23 skaters from the Winnipeg Newcomer Sports Academy. The event also welcomed seven National Team and NextGen members, as well as 20 volunteers.

We will now play a short video produced at that event.

Debra Armstrong

Progress does not happen without challenge and we also experienced a fair number of challenges in 2022-2023. Many clubs had trouble acquiring ice time and CanSkate programs were filled to capacity. In addition to this, the inflationary economy has made what we do more expensive. We are also facing the reality that all sections across the country are experiencing pressure on their base of volunteers which has traditionally been a pillar of how we deliver skating in Canada.

Committee Report:

1. ISU Congress and proposals

In lead-up to the 2022 ISU Congress (June 2022), the committee evaluated all Rule, Regulation and Constitution change proposals and held meetings with various stakeholders prior to and during the Congress to ensure key proposals were passed. The Skate Canada Congress Team on-site was successful in securing the election of Benoit Lavoie to the position of Vice President, Figure Skating. Congratulations to Benoit in his new leadership role! The direct line of communication via Benoit will certainly aid in our efforts to ensure that Skate Canada's strategic priorities are understood particularly as it relates to critical areas such as competitive athlete age limits and equity, diversity, and Inclusion issues.

2. Event hosting strategy

The committee established a hosting strategy prioritization chart with a focus on international events. Following robust discussions, the committee agreed upon primary and secondary objectives for each event. With this clarity, management will redraft the event hosting strategy for presentation to the Board of Directors.

3. Appointments and succession planning

Skate Canada regularly appoints individuals to various committees with external domestic bodies. For many of the domestic appointments, a member of the management team is appointed.

Annual succession planning focused on both domestic and international roles with the ISU and the Canadian Olympic Committee. Candidates have been identified and interest assessed. Where gaps have been identified in terms of readiness or qualifications, collaboration has occurred with management and in turn with the respective operating committee if applicable.

Appointments and Elections in the 2022-2023 season include:

4. ISU initiatives

The committee discussed the challenges of hosting **international synchro events** in North America. The committee identified various options going forward including remote scoring and further engagement with other Member Federations in the Americas, Four Continents, the ISU Technical Committee, and the ISU Development Commission.

Regarding international solo dance events, the committee supports this ISU initiative and acknowledged that the approach domestically may be different from the ISU given our strategic imperative of Skating for Life.

Committee Report:

The Membership Policy Committee is devoted to listening to the members of Skate Canada and our committee members, who are representatives from across the country. The Membership Policy Committee met seven times by video conference call. Each meeting included standing agenda items bringing valuable information and feedback for discussion. Besides topical items of interest, the agenda has standing items for continuity that provide information and discussion points. These items include:

- Report from Hilary Quick, the Chair of the Sections Coordinating Committee (SCC)
- Report from the National Service Centre (NSC)

Through discussions with Management, we determined a significant focus of the MPC for the 2022-23 season would be approval policy and minimum operating standards for Club and

Skating Schools. These became additional standing agenda items and garnered most of the Committee's time and attention.

Club and Skating School Minimum Operating Standards

We reviewed the various Skate Canada membership policies currently in place. Committee members gathered information from Sections, Clubs and skating schools regarding policies offered. These items covered many aspects and led to discussions on the accountability of clubs and schools on member engagement, communication, and risk. We created a comprehensive list of policies and recommended levels of accountability from Skate Canada to Sections, Clubs and Schools for integration and requirements for Club minimum operation standards. The goal is to provide a list of policies that would provide best practices at the National, Section and Club level for clubs and skating schools.

Club and Skating School Approval Policy

We created a flow chart to help potential clubs and skating schools navigate the application process. The chart starts with the initial application for membership approval and includes a process for appeals. Besides the initial application process for clubs, a measuring tool for club/skating school compliance, like the Coach Dashboard, was recommended to monitor the compliance and accountability of club membership and quickly identify clubs in Good Standing. The Committee also recommended a probation period for new clubs and schools. These recommendations have been brought forward for review by management and staff.

There were many discussions on each of these topics. Through each process, more questions arose that needed consideration so that the recommendations would cover the size, location and capacity for all clubs and schools and simultaneously provide consistency and accountability by the clubs to Skate Canada.

Other items on the workplan for 2022 – 2023 included:

- Memberships Policy Functions and Reviews
- Membership engagement This is an ongoing focus of the Committee monitored through dialogue with the SCC, the NSC and agenda items brought forward by committee members.
- Monitoring return to normal operations and program delivery across the country membership numbers continued to increase at higher-than-expected levels creating challenges with access to coaching, assessments, and ice times.
- Assessing member communications in line with strategy and goals. Discussion around program delivery and consistency, including assessments and program standards.

The NSC kept the MPC apprised of the plans and subject matter for workshops at the Ice Summit.

The work of the Membership Policy Committee is invigorating, as the discussion topics are never static; they reflect current issues, whether they be challenges or celebrations. The Committee is a collective of people from across the country, each bringing a unique perspective and contributing to fulsome discussions to serve the membership better.

As it was my first time chairing this Committee, I must thank my committee members for their contribution, support, and meaningful engagement this past year. We endeavour to keep our finger on the pulse of essential matters impacting our members across all sections. I also thank the National Service Centre staff who were tremendously supportive and guided – Debra Armstrong, Mary Ellen McDonald, Jeff Partrick, and Breanna Schmeer.

The Recruitment and Development Committee (RDC) is tasked with identifying skills and competencies required to support and provide oversight of Skate Canada through an Engaged Policy Board structure. The RDC is also responsible for Board succession through the recruitment of candidates for available Board positions.

Committee Report:

Members of 2022-2023 RDC worked as a collaborative and focused group. The committee met 5 times over the season, all by videoconference. Highlights of the committee's activities include:

- 1. The RDC Terms of Reference and 2022-2023 Work Plan were revised to better reflect the evolution of the committee as it entered the third year as a standing committee of the Board.
- 2. The RDC launched a Board Educational Library for board members to access complementary educational resources to strengthen or further enhance knowledge across governance, leadership, communication, and finance areas.
- 3. The RDC continues to proactively seek out and incorporate strong governance practices into recruitment efforts, updating board application materials, resources and communications surrounding the nomination and election processes.

2023 Skate Canada AGM Finance Report Mary Ellen McDonald, Senior Director Operations

Thank you Karen. I will be providing a review of the 2022/23 audited financial statements.

Auditors Timeline

- November 28 December 2: Interim work PwC
- April 24 May 5: Audit work PwC
- May 17: FERM reviews audited financial statements and recommends approval to the Skate Canada Bord of Directors
- May 18: Skate Canada Board reviews the audited financial statements and recommends for approval by Membership at the Annual General Meeting



PriceWaterhouseCoopers LLP performed the audit.

As was the case last year we were able to have PwC on site for the audit. The ability to be in person greatly improved the efficiency and timeliness of the audit itself and allowed Skate Canada to be able to meet the requirements to have draft Financial Statements posted 20 days prior to AGM (May 5 2023) and to have the audited financial statements approved by the Board and available to the membership for approval at the AGM.

The audit was conducted using the new audit standard CAS315 – Identifying and Assessing the risks of material misstatement. The audit risk model has not changed however the standard has been

significantly revised, reorganized and enhanced to require a more robust risk identification and assessment in order to promote better responses to the identified risks.

A responsibility of the auditor is to issue an opinion as to whether the financial statements are free of material misstatement. PwC was able to issue such opinion and more importantly there were no items resulting from the audit that required Skate Canada staff to make adjustments to the FS.


STATEMENT OF FINANCIAL POSITION

First Arrow

- Careful cash management of the operations has been required throughout this fiscal year. It was known last year COVID relief funding/relief was to be suspended by the Federal government as well as the ISU and therefore there would be a negative impact on cashflow. As many of you have seen in your Sections, clubs and personal lives the cost of living has increased significantly, which for Skate Canada in particular, resulted in expenditures being greater than originally anticipated for the fiscal year 2022 2023. Many of our expenses are commodity price driven meaning that we will have cost increases passed onto us as the final consumer of the services. This though does not translate into an equal and offsetting revenue increase. Items such as registration fees, insurance recoveries, event ticket prices are set in advance of knowing the true impact of these increases and therefore resulting in a mismatch from a recovery basis.
- Prepaid expenses the increase is due to payment of certain ISU 2024 World Championships expenses in advance of the event which will be held in March 2024 in Montreal.
- Investments The investment market has been experiencing swings which have impacted returns. There were periods of significant unrealized gains offset by unrealized losses. In 2022 both the bond and stock markets were down for the first time in 50 years and the 3rd time since 1930. The bond market is expected to improve in 2023 which should result in some recovery in the Skate Canada portfolio. Interest rates had been predicted to increase in 2022 and Skate Canada with the assistance of BMO (our investment advisor) moved fixed income instruments into a one year GIC. Upon maturity of these GIC's in February 2023 Skate Canada reinvested all but \$2,000,000 into the bond market and high interest savings accounts. The \$2.0M was transferred to the current cash account. This is in anticipation of cash outlays on account of

Worlds 2024 prior to receiving monies from our funding partners as well as revenue from ticket sales.

Capital Assets – Skate Canada is investing in long term Technology projects which is creating
an increase in Work in Progress in Capital Assets. The external costs associated with Digital
Transformation and Virtual Hall of Fame projects will be capitalized until they are "commercially
viable" and then the costs will be expensed as amortization in the financial statements.



- Major changes in Accounts payable and accrued resulting in overall increase of \$482K is:
 - Accounts payable increased approximately \$300K over 2022 and this is due to the invoices being outstanding for payment on account of World Junior Championships
 - Accrued liabilities increase year over year \$180K due to higher Section payments as a result in increased registrant activity.

Net Assets have decreased and will be explained in more detail through the Statement of Operations explanations.

You will notice that I have an arrow pointing to the bottom of the page where it is seen that the President and CEO sign/certify the financial statements immediately after the review with the Board and approval of statement. This is in a similar fashion as for profit organizations. It is a further display of strong governance practices.

2023 AGM

Revenue: For the 12 months ended March 31, 2023, there is an overall increase in revenue of \$4.106M from March 31, 2022, with the details of the changes outlined below.

Membership: Registration revenue increased \$1,670,751 or 23% from prior year. The current year has seen a month over month increase in registrants resulting in registrant figures that are the largest in Skate Canada recent history. The changes are:



Assessment Fees: Assessment revenue increased by \$360,252 or 55%. The increase in registrants is one of the factors contributing to the increase in this revenue line item. The other is that the delay in skill acquisition as a result in COVID closures is lessening resulting in more skaters being ready for assessments in the current fiscal year.

Events: The events revenue increase of \$3,858.533 over 2021/22 event season is primarily a result of Skate Canada hosting 2 international events – 2022 World Synchronized Skating Championships (\$1,354,597) and the 2023 World Junior Figure Skating Championships (\$2,305,924).

Government and Other: The decrease in this revenue line item is \$1,663,535 and is primarily due to government support of businesses through special COVID funding ending resulting in a decrease of \$1,300,000 in the current fiscal yar. The remaining variance is the reduction in enhanced excellence COC/OTP funding of \$357,500.

Skate Canada Statement of Operations For the year ended March 31, 2023



Expenses: For the 12 months ended March 31, 2023, there is an overall increase of expenses of \$6,784,419 from March 31, 2022, with the details of the changes outlined below.

Section Payments: The increase of \$1,110,028 is as a result of the increase in registrant volume and assessments taken. 50% of registrant fee of \$40.00 is paid directly back to the Section as is 30% of assessment fees and 20% of coach fees. These monies are paid to provide the sections with monies to support programming, coach development and officials development.

Events: Event expenses were \$3,824,674 higher than in 2021/22 fiscal year due to the execution of 2 international events (\$3,258,147), change in event execution strategy to align with the Long Term Development model, and general increases in commodity-based pricing which impacted all events executed during the year.

Human Resources: The increase of \$378,003 is the annualization of filled positions and the first year since 2019/20 that Skate Canada has returned its staff complement to pre COVID levels.

Professional fees and Contracted Services: The increase in expenses is as a result of increase legal costs as a result of Safe Sport as well as increases for streaming content for Skate Canada hosted events.

Traveling /Living: 2022 2023 is the first year since COVID of full year travel to international events, in person Board and SCC meetings, as well as execution of NextGen and High performance camps.
